On behalf of the Board, RHB Investment Bank wishes to announce the following with regards to the Listing:

1. LEVEL OF SUBSCRIPTION OF PUBLIC BALLOTING AND PLACEMENT

(a) Malaysian Public via balloting

Under the Malaysian Public portion, a total of 72,500,000 Issue Shares were made available for application by the Malaysia Public through a balloting process of which:

- (i) 36,250,000 Issue Shares were set aside for application by Bumiputera public investors ("**Bumiputera Portion**"); and
- (ii) 36,250,000 Issue Shares were set aside for application by other Malaysian Public investors ("**Other Malaysian Public Portion**").

A total of 5,512 applications for 206,640,400 Issue Shares were received from the Malaysian Public, representing an overall oversubscription rate of approximately 1.85 times, where:

- a total of 2,601 applications for 80,838,700 Issue Shares were received from Bumiputera public investors, representing an oversubscription rate of approximately 1.23 times; and
- a total of 2,911 applications for 125,801,700 Issue Shares were received from other Malaysian Public investors, representing an oversubscription rate of approximately 2.47 times.

(b) Private placement to identified institutional and selected investors

The 122,649,800 Issue Shares made available by way of private placement to identified institutional and selected investors have been fully placed out.

(c) Private placement to identified Bumiputera investors approved by the MITI

The 90,450,200 Issue Shares and 90,000,000 Offer Shares made available by way of private placement to identified Bumiputera investors approved by the MITI have been fully placed out after applying the relevant clawback and reallocation provisions as set out in the Prospectus.

(d) Eligible persons

The 24,400,000 Issue Shares reserved for application by the Eligible Persons have been fully subscribed.
